## THE CITY OF SEVIERVILLE, TENNESSEE

FOR

## FLOOD CONTROL AND DAMAGE PREVENTION

THIS AGREEMENT, made and entered into this 1st day of July, 1965, by and between Sevier County, Tennessee, hereinafter called "County", and the City of Sevierville, Tennessee, hereinafter called "City".

## WITNESSETH

WHEREAS, on April 12, 1965, the City entered into a written agreement with the Tennessee Valley Authority, providing for cooperative action between the City and the TVA for the construction of a flood control and damage prevention project for the City and County, which project will be constructed partially within, and partially without, the Corporate Limits of the City, a copy of which contract is hereto attached and made a part hereof by reference; and

WHEREAS, under the terms of said contract, it is necessary for the City to provide approximately \$440,000.00 in local funds for the construction of said project and an additional amount of approximately \$6,000.00 per year for the maintenance of said project after construction is completed; and

WHEREAS, the County recognizes its obligations to contribute to the required local funds for construction and its obligation to contribute to the maintenance of said project after construction thereof has been completed.

NOW, THEREFORE, in consideration of the premises and in order to meet its said obligations, the County hereby agrees to contribute one-third of the necessary local funds for construction of said project, not to exceed \$7,500.00 per annum, plus interest on said amount for a period of 20 years, the first annual payment to be made to the City during the fiscal year beginning July 1, 1965, and each year thereafter, upon request of the City; and in addition, the County agrees to provide one-third of the annual maintenance cost of said project upon completion of construction thereof, not to exceed \$2,000.00 per annum, the first payment to be made during the first fiscal year beginning after the completion of said construction, and annually thereafter, upon request of the City.
